Outdoor Coatings Limited Warranty

Armortech Premium Coatings, Inc., herein referred to as APC shall warrant its outdoor coatings for a period of one year from its purchase date, providing the application has been done in accordance with APC's preparation and application instructions, recommendations, procedures and that the warranty registration is completed within 10 days of product arrival date. The warranty period is one year from the shipment arrival date with registration. This warranty shall cover APC's applicable coatings against manufacturing defects, peeling, or blistering for a period of one year.

The customer agrees that APC's exclusive remedy and the entire liability of APC concerning specified coatings are set forth in this agreement. APC shall not be liable to the customer for any damages, including lost profits or other incidental damages arising out of its use of the product or the breach of said warranty. APC shall not be responsible for any labor or labor-related charges and specifically warrants that our only liability is the replacement product for the affected area. APC's Outdoor Coatings warranty shall be limited to the replacement of a complete like quantity of original purchased materials or at its option, credit towards another APC product.

Warranty claims for failures within 14 days of application must supply information requested by APC for warranty consideration. APC, at its request, may require surface, moisture or concrete testing to be performed at the purchaser's expense and for the providing of photographs or other documentation, including proof of purchase.

This warranty shall be governed by the laws of WA and any actions or litigation thereof shall be filed and conducted within the state of WA. The warranty does not include the cost of labor or shipping charges. The warranty is limited to a total replacement quantity not to exceed the original purchase amount quantity.

CONDITIONS NOT COVERED UNDER WARRANTY

- Improper hardening is not covered under the warranty as it is caused by improper mixing or high moisture levels in the floor.
- Failures from hydrostatic pressure (moisture under the concrete) which can cause bubbling, blistering, peeling, and softening.
- Mixing and/or application issues, such as the product reaching its pot-life prior to application, where the material begins to get hard or smoke in the bucket.
- The product not curing due to improper mixing.
- Failure from adhesion loss to another previously coated or sealed surface.
- Oils, contaminants, and other sub-surface conditions present in the floor.
- Acids, salts, or alkalis present in the floor.

- Deficient concrete (loose, cracked, broken, or spalled concrete) with reduced adhesion characteristics or deficiencies.
- Application problems due to uneven concrete and asphalt, porous concrete and asphalt, and inconsistent concrete and asphalt absorption rates.
- Wear Resistance.
- Conditions that affect appearances, such as gloss loss or tire marking/stains.
- Applications with chemicals, solvents, fuels, oils, or salts present in the floor.
- Yellowing of epoxy that was applied without a proper protective topcoat.
- Armortech Premium Coatings Inc. shall not be responsible or in any way liable if the product cracks, heaves, or delaminates due to substrate settling, water intrusion, ground movement, earthquakes, impact damage, hydrostatic pressure, acts of God, or negligent acts of others. Any staining, scratching, chipping, or cracking of the product which may result from such movement, intrusion, or negligence is not warrantied.
